Mandatory Release and Assumption of Risk

Please carefully read the following "Mandatory Release and Assumption of Risk" prior to signing below.

I am aware that travel, in civilized, uncivilized or remote areas and whether by aircraft, canoe, boat, or by any other conveyance, or on foot, skis, powered snow machine, dog sled, horseback, or any other method, contains some inherent risks of illness, injury, delay, or death which may be caused by the negligence of others, forces of nature, wild animals or other agencies known or unknown. I recognize that such risks may be present at any time before, during, or after the trip that I am participating in under the arrangement of TT Enterprises / Great Canadian Wilderness Adventures and its agents, affiliates, or associates. I am also aware that medical facilities and services may not be readily available or accessible during part or all of the time during which I am participating on the trip. In consideration of, and as partial payment for the right to participate in the trip and the activities, food, and other services arranged for me by TT Enterprises / Great Canadian Wilderness Adventures and its agents and associates in connection with the trip, I have and do hereby fully assume all risks of illness, injury, delay, or death, and hereby fully discharge and release TT Enterprises / Great Canadian Wilderness Adventures and its agents and associates from all actions, claims, or demands from damages resulting from my participation in the trip. I agree that the foregoing obligation shall be binding upon me personally, as well as upon my heirs, executors, and administrators, and all members of my family, including any minors accompanying me.

Neither TT Enterprises / Great Canadian Wilderness Adventures nor any of its subcontractors are in any way responsible for delays or any additional costs incurred due to delays relevant to forces of nature, ice or weather conditions, aircraft or vehicle mechanical, changes in operational logistics, or other agencies known or unknown, which can all affect safe operations in the remote Arctic & sub-Arctic. TT Enterprises / Great Canadian Wilderness Adventures reserves the right to alter all expedition and/or charter flight itineraries, trip leader assignments, expedition starting and finishing points, dates, camp locations, etc. without prior notice.

TT Enterprises / Great Canadian Wilderness Adventures does not guarantee wildlife sightings. Even though wildlife is often one of the main attractions on many of the advertised tours, I fully understand prior to participating on the trip that actual wildlife & wild animal sightings and encounters and the frequency or lack thereof are natural elements beyond anyone's control. I fully understand prior to joining the trip that neither TT Enterprises / Great Canadian Wilderness Adventures nor any of its agents, associates and subcontractors are in no way responsible for wildlife behavior, nor responsible for the failure or success of animal sightings while I am participating on the trip.

I understand that my deposit is non-refundable. However it may be transferred to another suitable person or to another trip of your choice departing within the same season or the next, if there is space available. I understand that I can do this just once, and only if the transfer to another trip is accompanied by another deposit. The final balance owing is due in full ninety (90) days prior to the trip departure. The balance owing amount is refundable, and will be forwarded back to me by registered mail within sixty (60) days of written notice of cancellation. This applies to up to thirty (30) days prior to departure, after which the entire balance is forfeited. There is a seventy-five (75) lb. weight limit on all charter flights that we organize on your behalf. I acknowledge that I have read TT Enterprises / Great Canadian Wilderness Adventures booking information including its policies on cancelled trips and refunds, clearly understand its content, and agree to all conditions set forth within.

It is mandatory that all TT Enterprises / Great Canadian Wilderness Adventures trip members must read and endorse this release contract prior to departing on all expeditions. I have carefully read this agreement and fully understand its contents. I am aware that this is a release of liability and a contract between TT Enterprises / Great Canadian Wilderness Adventures and its affiliated organizations, and I sign it of my own free will."
